In the Fiscal Year ending June 30, 2008 of the youth who received services in our Interface shelters, 100% were not adjudicated while working with our staff and 85% completed our shelter program.

In our non-residential Family Action program 96% of youth served successfully completed services.

In our Adolescent Substance Abuse Treatment program 82% of youth served completed the program.

Last year 325 parents and youth completed satisfaction surveys with 97% reportingk overall satisfaction with services received.

INTERFACE (Residential Services)

Interface is a shortterm youth shelter for children ages 10 to 17. It is open 24 hours a day, 365 days a year. Once at Interface, a trained staff member talks to youth about their situations and explains how the program works. Youth who decide to stay can count on a safe place to sleep, food, clothing, and personal support. Trained staff also provide crisis stabilization. counseling, and help youth address short-term needs and long-term goals.

TRUANCY CENTER

The Gainesville IYP shelter accepts actively truant students in the

Alachua County area. Law enforcement bring in youth who are not attending school, and the staff provides counseling and intervention services. This program is a collaborative effort with the School Board of Alachua County, Gainesville Police Department and the Alachua County Sheriff's Office.

Major Accomplishments During 2008:

419 youth made use of the Interface Youth Shelters and 22 youth were served through the Truancy Center.

Interface Central was awarded a Federal Basic Center grant to serve runaway and homeless youth.

Family Action Program

The Family Action program provides short-term counseling to families with youth ages 6 to 17 who are having trouble following rules, are truant from school, have runaway, or who are threatening to runaway. Via family and individual counseling, we work to provide youth and their families with the tools necessary to meet the challenges they face.

The Family Action Program is available 24hours a day, every day, and is free of charge for all basic services. Family Action usually takes 12 weeks to complete based on the needs and concerns of the family.

Major Accomplishments During 2008:

Family Action served 526 young people and their families during the year.

96% of youth served successfully completed services.

61% of the youth served were targeted due to risk factors associated with living in high-risk neighborhoods.

For many years our Outpatient Services program had been the substance abuse treatment provider for both Alachua County's Drug Court and Day Reporting programs. As a cost saving measure this year the County took these programs back under the auspices of Alachua County Court Services.

This action created an opportunity for CDS to review the structure of our substance abuse operations and the decision was made in December of 2008 to incorporate the Outpatient Services program under the Drug Free Communities program.

It is expected that moving the two programs to the same location will result in a series of efficiencies, ultimately improving service delivery to adults, youth, and families.

The Drug-Free Communities Program provides substance abuse education, intervention, drugtesting, and counseling to adolescents and adults in our community. Individuals referred to the proare gram by a variety of sources — some of which are the State Attorney's office, Teen Court, school systems, the Department of Children and Families, the Partnership for Strong Families, and the US Federal Probation Office.

At times, services are provided in lieu of prosecution for youth and adults or as a suspension-reduction alternative for youth in school. Other times, youth or their parents request help. Services are provided at our offices, in schools, and even in the participants' homes.

Major Accomplishments During 2008:

We provided substance abuse services to 282 youth and 330 adults.

We provided counseling and other services to 109 adults experiencing economic instability due to substance abuse or mental health issues through our Temporary Assistance for Needy Families (TANF) program.

We developed the Anti Drug Initiative program (ADI) in cooperation with the State Attorney's Office and with support from United Way of North Central Florida. This program is designed as a deferred prosecution option for misdemeanants with substance abuse issues in need of short-term intervention.

SAMH-East

The SAMH-East Program provides outpatient counseling for youth abusing drugs, or who have risk factors for substance dependency, such as a parent with addiction issues. The services of the program include treatment, intervention, and education for young people who are experimenting with or abusing drugs. On average, youth stay in the program for four months.

Other SAMH-East services include TASC (Treatment Alternatives for Safe Communities), which provides assessment and

referral services; and TANF (Temporary Assistance for Needy Family), which provides counseling and other services to families experiencing economic instability due to substance abuse or mental health issues.

Major Accomplishments During 2008:

This year, 105 youth received outpatient counseling, 102 youth received TASC services, and 162 youth and adults received TANF services.

Independent Living is a program of counseling, case management, and education for youth and young adults ages 13 to 23 who are or have been in the care of the Partnership for Strong Families. Services provided to youth and young adults range from needs assessment and service plans to individual instruction on necessary life skills.

Counselors / Case managers also assist in locating student housing, negotiating financial assistance forms, and finding overlay services to ensure success (such as tutoring).

Major Accomplishments During 2008:

This year we served 238 youth.

We had 14 youth graduate high school or receive their GEDs in the past year.

One young adult graduated from community college and is currently employed by the Alachua County Sheriff's Office.

58 of our young adults are involved in post-secondary education.

We had 4 young adults working for Department of Children and Families over the summer through "Operation Full Employment".

Prevention Services

Prevention The Program provides substance abuse education and resources primarily for youth and adults in Alachua and Levy counties. Program Services include inschool programs, training workshops, educational seminars and chemical-free events.

This year the Prevention Program received continuation funding from the Florida Department of Juvenile Justice for Project Turnaround, a civil citation diversion program designed to offer first-time offenders an opportunity to be diverted from the Juvenile Justice System. Youth in Project Turnaround are required to complete community service hours and to attend classes on theft awareness. substance abuse, and aggression management. Youth are also required to write apologies to the people they have victimized.

If the young person completes all requirements within 45 days, his/her citation will be voided.

This program has provided second chances to 111 youth during this year.

Major Accomplishments During 2008:

Alpha and Beta Program personnel provided assessment and counseling services for 51 elementary and middle school students in Williston. Our "Too Good For Drugs" program reached 811 students at Williston Elementary and Middle schools.

The Partners In Prevention of Substance Abuse Coalition (PIPSA) continues to work under a grant from DCF to collect data and develop a Community Action Plan to address "Underage Drinking" for Alachua County.
