INTERFACE (Residential Services)

Interface is a shortterm youth shelter for children ages 10 to 17. It is open 24 hours a day, 365 days a year. Once at Interface, a trained staff member talks to youth about their situations and explains how the program works. Youth who decide to stay can count on a safe place to sleep, food, clothing, and personal support. Trained staff also provide crisis stabilization, counseling, and help youth address short-term needs and long-term goals.

TRUANCY CENTER

The Gainesville IYP shelter accepts actively

The Family Action program provides shortcounseling to term families with youth ages 6 to 17 who are having trouble following rules, are truant from school. have runaway, or who are threatening to runaway. Via family and individual counseling, we work to provide youth and their families with the tools necessary to meet the challenges they face.

The Family Action Program is available 24hours a day, every day, and is free of charge for

truant students in the Alachua County area. Law enforcement bring in youth who are not attending school, and the staff provides counseling and intervention services. This program is a collaborative effort with the School Board of Alachua County, Gainesville Police Department and the Alachua County Sheriff's Office.

Major Accomplishments **During 2007:**

397 youth made use of the Interface Youth Shelters, and 31 were served through the Truancy Center. Interface East also moved into a larger, newlyrenovated site in Palatka.

Family Action Program

all basic services. Family Action usually takes 12 weeks to complete, and is available in Alachua, Bradford. Columbia. Dixie. Gilchrist, Hamilton. Lafayette, Levy, Putnam, Suwannee, and Union counties.

Major Accomplishments During 2007:

There was an increase in the number of youth and families served by the program. Family Action served more than 330 young people families during the year!

Drug-Free Communities

The Drug-Free Communities Support Program provides substance abuse education, intervention, drug-testing, and counseling to adolescents in our community. Youth are referred to the program by a variety of sources- some of which include Teen Court, the State Attorney's office, school systems, the Department of Children and Families, and the Partnership for Strong Families.

At times, services are provided in lieu of prosecution or as a suspension-reduction alternative for youth in school. Other times, youth or their parents request help. Services are provided at our offices, in schools, and even in the participants' homes.

Major Accomplishments During 2007:

admission process Faster for youth is one major accomplishment. Young people are more likely to continue participating in services when we can respond quickly to their requests for help. We have also improved accessibility of our services by expanding the number of outreach (outof-office) sessions this year.

Outpatient Services

Outpatient Services provides adult substance abuse services to program participants from three criminal justice agencies: Alachua County's Drug Court Program; Alachua County's Day Reporting Program; and U.S. Federal Probation office.

Services include but are not limited to: screening individuals for alcohol and drug abuse problems, and education and counseling activities to improve the functioning (or to prevent the further deterioration) of persons with substance abuse disorders.

Major Accomplishments During 2007:

This past year, two significant accomplishments were the establishment of men's and women's groups for gender-specific counseling services, and better integration of services and deliverables regardless of a person's status with Drug Court, Day Reporting, Federal Probation, or TANF.

These two seemingly small changes have had a huge impact in the quality and effectiveness of services provided to our participants.

Children's Outpatient

Children's The Substance Abuse Program provides outpatient counseling for youth abusing drugs, or who have risk factors for substance dependency, such as a parent with addiction issues. The services of the program include treatment, intervention, and education for young people who are experimenting with or abusing drugs. On average, youth stay in the program for four months.

Other Children's Outpatient programs include TASC (Treatment Alternatives for Safe Communities), which provides assessment and referral services; and TANF (Temporary Assistance for Needy Family), which provides counseling and other services to families experiencing economic instability due to substance abuse or mental health issues.

Major Accomplishments During 2007:

About 85 youth have been served this year, 76 through TASC (Treatment Alternatives for Safe Communities).

Independent Living

Independent Living is a program of counseling / case management / education for youth and young adults ages 13 to 23 who are or have been in the care of the Partnership for Strong Families. Services provided to youth and young adults range from assessment and needs service plans to individual instruction on necessary life skills. Counselors / Case managers also assist in locating student housing, negotiating financial assistance forms, and finding overlay services to ensure success (such as tutoring).

Major Accomplishments During 2007:

We had 22 youth graduate high school or receive their GEDs in the past year. One young adult graduated from community college and is now attending the University of West Florida. About 50 of our young adults are involved in post-secondary education. Also in 2007, we began holding Youth Advisory Board meetings on the 1st Thursday of every month to advise our partner agencies on best practices and improvements for the Child Welfare System.

Prevention Services

Prevention The Program provides substance abuse education and resources primarily for youth and adults in Alachua and Levy counties. Program Services include inschool programs, training workshops, educational seminars and chemical-free events.

This year the Prevention Program received funding from the Florida Department of Juvenile Justice for Project Turnaround, a civil citation diversion program designed to offer first-time offenders an opportunity to be diverted from the Juvenile Justice System.

Youth in Project Turnaround are required to complete community service hours and to attend classes on theft awareness, substance abuse, and aggression management. Youth are also required to write apologies to the people they have victimized.

If the young person completes all requirements within 45 days, his/her citation will be voided.

This program has provided second chances to 32 youth since April of 2007.

Major AccomplishmentsDuring 2007:PreventionServices

personnel in our Alpha Beta Programs and provided assessment and counseling services for 47 elementary and middle school students in Williston. Our "Too Good For Drugs" program reached over 700 students at Williston Elementary and Middle schools.

The Partners In Prevention of Substance Abuse Coalition (PIPSA) received a grant from DCF to collect data and develop a Community Action Plan to address "Underage Drinking" for Alachua County.
