Family Action Counseling



Family Action Counseling provides short-term counseling to families with youth ages 6 to 17 who are having trouble following rules, are truant from school, have runaway, or who are threatening to runaway. We work to provide youth and their families with the tools necessary to meet the challenges they face. We are dedicated to promoting healthy communities by serving youth and families.

All families and youth experience crisis. Sometimes one or more crises may be going on at the same time in a family. Families may be able to handle and resolve most of these things quickly. But sometimes they have problems that push them to the limit. These problems might include a teenager or younger child who: skips school, runs away from home (or threatens to), will not follow directions, etc. Family Action can help you find ways to reduce or stop these

How it works



Family Action provides short-term counseling to individual youths and families. This program is available **24-hours a day, every day, and is free of charge** for all basic services.

Family Action usually takes 12 weeks to complete.

To qualify, youth must be under 18 and cannot be involved with foster care or adjudicated delinquent or

under the supervision of the Department of Juvenile Justice at the time of services.

Family Action begins with a simple screening process. The information gathered is used to determine what services the family is eligible for and what programs would best help the child.

Family Action works to repair broken communications between parents and children, and helps them find a better path. The program is available to residents of Alachua, Bradford, Columbia, Dixie, Gilchrist, Hamilton, Lafayette, Levy, Putnam, Suwannee

Conflict Resolution: Tips For Parents *



Before resorting to screaming and yelling, think about all your options for how to deal with a family conflict. You have several options: Suggest an alternative to what's being proposed; com-

promise; **resolve** the problem as a family; "sleep on it" so that everyone has a chance to cool down; use humor or surprise to lighten the mood; Order the necessary action, but do so clearly, calmly, and respectfully.

Children are also more likely to fight if they feel powerless, so give your child a voice in family discussions and decisions. Encourage your children to express all their feelings, even if they are angry or sad, and express yours too. You can also help matters by spending more time with your children, and taking every opportunity to bolster their self-esteem.

Lastly, be a good role model. Children learn general approaches to resolving conflict by watching *you*. How do you negotiate? Do you try to see the other person's point of view? Can you admit when you are wrong?
